## DIRECTIONS FOR USE

### DIRECTIONS FOR CIP CLEANING PIPELINES & TRANSFER SYSTEMS

1. Rinse equipment thoroughly and immediately after milking with warm water (95-110 °F). Drain.
2. Wash equipment using a chlor-alkaline CIP Detergent (min 160 °F water). Circulate solution for 8 to 10 minutes. Drain.
3. Acid Rinse equipment using 1 oz. Stronghold 1000 in 10 gallons coolwater. Circulate 2-3 minutes. Drain.
4. Sanitize equipment just prior to use. Use an EPA Dairy Sanitizer, 1 oz.per 2 gal. cool water. Circulate sanitizing solution for at least 2 minutes. Drain.

### FOR CIP CLEANING OF BULK TANKS

1. Rinse tank thoroughly with 100 F water immediately after emptying. Drain.
2. Wash tank using an Alkaline CIP Detergent according to directions (min 160 F water). Close lids and circulate solution 8-10 minutes. Rinse tank inside and out with cool water. Drain. Dismantle and wash outlet valve in cleaning solution. Rinse and assemble valve.
3. Acid Rinse tanks with 1 oz Stronghold NP1000 in 10 gallons of cool water. Drain.
4. Sanitize equipment just prior to use. Use an EPA Sanitizer, 1 oz. per 2 gal. cool water. Circulate sanitizing solution for at least 2 minutes. Drain.
