Section 4. First Aid Measures

- In case of eye contact : Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Contact ophthalmologist immediately.

Section 5. Fire Fighting Measures
