### Section 6. Accidental Release Measures

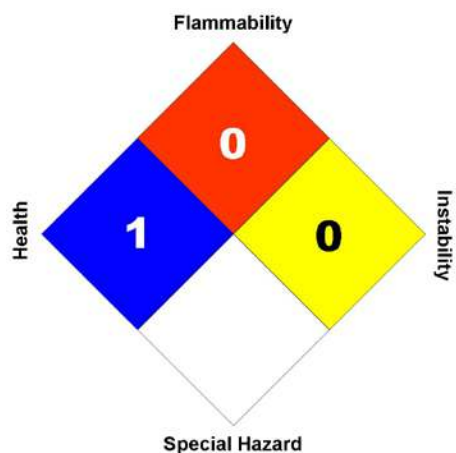
