### Section 4. First Aid Measures

Mobility in soil : Peracetic acid released in the environment will partition almost exclusively (>99%) to the water compartment. Only a minor part

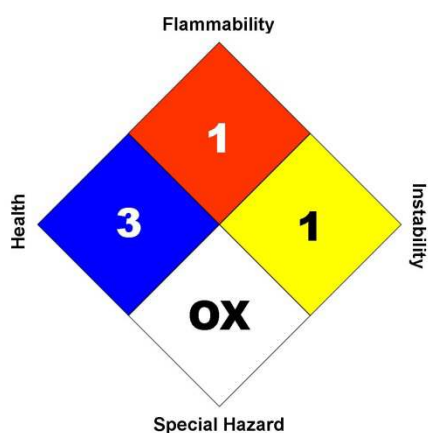
