### Section 4. First aid measures

### Section 5. Fire-fighting measures

Suitable extinguishing media : Use dry chemical, CO<sub>2</sub>, water spray (fog) or foam.

Unsuitable extinguishing media : Do not use water jet.

### Specific hazards arising from the chemical

Combustible liquid. Runoff to sewer may create fire or explosion hazard. This material increases the risk of fire and may aid combustion. Heating may cause a fire. May re-ignite itself after fire is extinguished. Hazardous decomposition may occur. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. ### Section 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Avoid breathing vapor or spray. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment.

### Methods and materials for containment and cleaning up

Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Avoid contamination with reactive substances. Dilute with water and mop up if water-soluble. Do not absorb in sawdust or other combustible material. It may lead to a fire risk when it dries out. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Absorb spillage to prevent material damage. Dispose of via a licensed waste disposal contractor.

### **Precautions for safe handling**

Put on appropriate personal protective equipment. Do not get in eyes or on skin or clothing. Do not ingest. Avoid breathing vapor or spray. Wash hands thoroughly after handling. Do not enter storage areas and confined spaces unless adequately ventilated. Store and use away from heat, sparks, open flame or any other ignition source. Use explosion-proof electrical (ventilating, lighting and material handling) equipment. Use only non-sparking tools. Keep away from clothing, incompatible materials and combustible materials. ### Conditions for safe storage, including any incompatibilities

To avoid the risk of formation of shock-sensitive crystals or loss of stability, it is important to store the product within the recommended temperature range. Temperature control may be required. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink.
