Section 4. First Aid Measures

Section 5. Fire-Fighting Measures

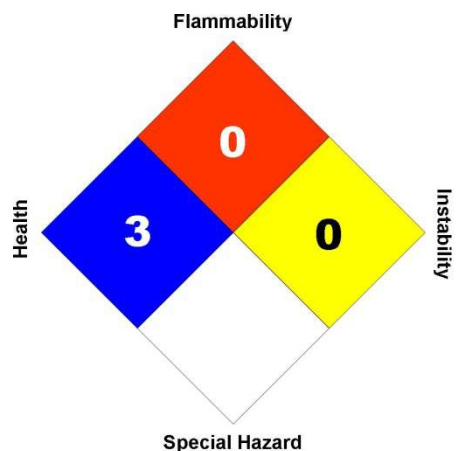
