Section 5. Fire-Fighting Measures

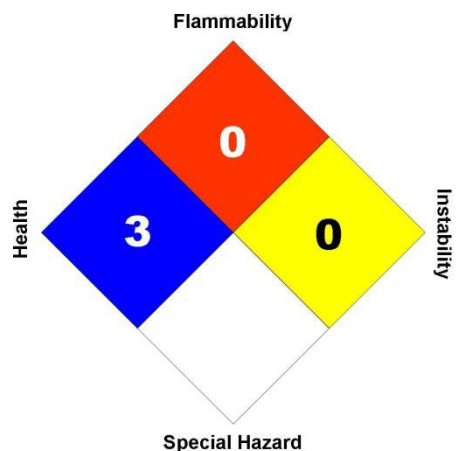
