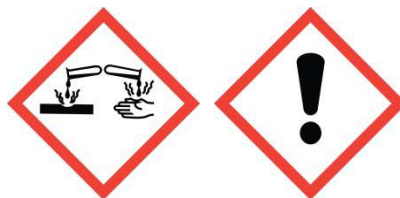

Section 4. First Aid Measures

Section 6. Accidental Release Measures

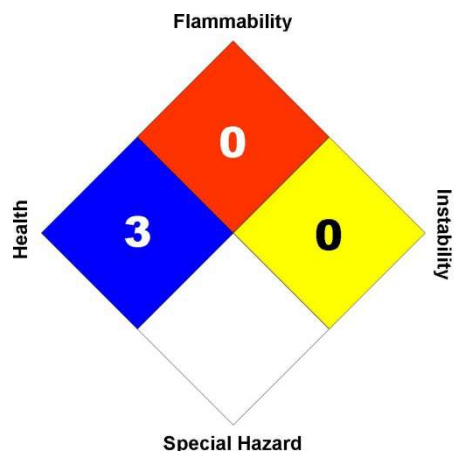
